Advice for Applicants

Application Due Date

Applications must arrive by the date shown on the application form. No undertaking is given to accept late applications.

Referees

It is the applicant's responsibility to contact referees and ask them to submit their reports on time and to the correct office.

References must be clearly marked with the applicant's full name and the name of the scholarship for which it is being submitted.

It is preferred that references are on the appropriate letter head paper.

Curriculum Vitae

The Curriculum Vitae should be succinct and no more than two pages.

Eligibility - 'a New Zealand University law degree'

Subject to all other eligibility criteria being satisfied 'a New Zealand law degree' is taken to mean the Bachelor's degree or the first New Zealand law degree.

Eligibility - 'gained the qualifying degree within the past five years'

Note that the time limit has been extended from 3 to 5 years.

The date from which the five years are counted is the 'conferred', 'awarded' or 'granted' date of the qualifying degree as recorded on the applicant's university academic transcript.

Any 'exceptional circumstances' that an applicant wishes the committee to consider in order to achieve eligibility outside the five year limit must be included with the application.

Budget Information

Applicants must use the table on page 6 of this application form.

A layout of different design must not be substituted.

If notes are needed to explain elements of the budget these can be added on a separate sheet.

If alternative universities are still being considered a budget should be included for each one.

Applicants who are invited for interview will be asked to provide an updated budget.

Documentation

Do not send original birth certificates or other original documents. Send only copies that have been certified by a J.P., a solicitor or a university staff member.

Universities New Zealand accepts no responsibility to return any documents.



Application Layout

Do not put the application into any sort of folder. Do not double side any pages. Attach all pages with ONE staple in the top left hand corner. All pages should be A4 size.
