

# Briefing into postgraduate scholarship and stipend support in the university sector

March 2023

## Introduction

This paper is provided in response to the 9 January 2023 request from the Education and Workforce Select Committee for information to help understand what scholarship and stipend support is available to postgraduate students.

The paper includes information on scholarships at each of New Zealand's eight universities along with some analysis and commentary from Universities New Zealand.

Universities New Zealand is the operating name of the New Zealand Vice-Chancellors' Committee, a statutory body established under Section 311 of the Education and Training Act 2020 to exercise functions such as determining what university qualifications can be offered, and making recommendations on criteria for entrance to universities.

## **University-funded scholarships**

New Zealand's eight universities together disbursed more than \$82 million on scholarship stipends for students at levels 9 and 10 in 2022. For all the main university-funded scholarship schemes, universities also covered tuition fees—another \$30-\$40 million of foregone revenue. On top of this, universities paid for personnel and associated overhead costs for administering and managing these scholarships.

All universities know there are many capable students who would either not be able to study—or whose studies would be seriously compromised—if they did not have a scholarship. Students from traditionally poorly served backgrounds (especially Māori and Pacific students) are often the first to lose access due to financial constraints.

As public-good, not-for-profit entities, universities have long regarded provision of support for postgraduate students a core mission and legitimate investment in our collective future.

However, the amount allocated to postgraduate scholarships must be balanced against all the other items universities must pay for. Over the past decade, funding per student has declined by 16% in real terms while university costs have typically increased by around 1.4 times the consumer price index.

All universities are increasing the stipends paid to doctoral students for 2023 to reflect cost-of-living realities arising from inflation running at over 7%. However, university tuition fees and tuition subsidies are rising only 2.75% this year (both are controlled by Government) and PBRF funding has not risen again this year – or in fact any year since 2017/2018.

These mean that universities are generally not able to increase the pool of funding available for doctoral scholarships, or to increase it at the rate they know is necessary if New Zealand is to flourish as a society. To offset increased stipend rates, many universities will be reducing the number of scholarships awarded. Furthermore, an increased investment in scholarships to support postgraduate students inevitably means lower levels of investment in other areas of research across the university.

Though the available pool of funding is a key factor in how many students can be offered a scholarship and at what level, regional differences in the cost of living (particularly for housing) are also a consideration in the stipend rate set by each university.

## The importance of supporting postgraduate studies.

The ability for students to support themselves financially over the period of their studies is a key factor in being able to undertake study at any level.

In 2013, eligibility for student allowances was removed for students studying postgraduate qualifications above Level 8 (Honours). Before 2013, around 18% of postgraduate students received an allowance. This relatively low percentage did not reflect demand but rather was influenced by the fact that most students were limited to a total of five years of allowances across all tertiary studies.

In 2018, Motu Economic and Public Policy Research Trust (Motu) examined the impact of the 2013 decision and found no obvious subsequent impact on: demand for postgraduate study; student choices between full and part time study; borrowing; the amount of paid work carried out during studies; and student dropout rates. However, Motu did not consider the counterfactual—the potential upside for the country and for students themselves if financial settings encouraged *more* students to undertake postgraduate studies.

New Zealand has some major challenges to overcome in the coming decades. We want a cohesive, prosperous society built on wellbeing and inclusion, which can only be achieved if we diversify and grow our economy. Economic growth needs innovation, entrepreneurship and increased productivity, but that must be balanced with our responses to challenges such as climate change, natural resource depletion and quality of life.

We will struggle to solve all these problems without a stronger research and innovation system—and that system depends on postgraduates. At present, just 1.4% of New Zealand GDP goes into research, compared with an OECD average of 2.7%. As well as requiring more public spending in areas where research leads to public-good outcomes, company investment in research innovation should grow to enhance economic diversification and productivity growth. This will happen only when companies have access to ideas worth investing in and people to generate and develop them.

At present, just 7% of New Zealand's workforce has a postgraduate (research) qualification, compared with an OECD average of 15%.

The table below shows the percentage of the population in New Zealand, Australia, Canada, the UK and the US enrolled in masters or doctoral studies in 2013 and in 2020. New Zealand is experiencing real growth, but we still have just 0.274% of our population studying at these levels compared with an average that is nearly double that (0.508%).

Until we put more support around getting people into and through postgraduate studies, we will never get close to that OECD average. We will also never see a post-graduate qualified workforce that better reflects our general population—particularly Māori and Pacific, but also women in some fields.

## What support do postgraduate students receive now?

Students in honours (Level 8) programmes continue to have access to allowances. Students in masters (Level 9) or doctoral (Level 10) programmes do not.

Some students are able to gain financial support through scholarships, which take a number of forms.

Universities offer and pay for some scholarships themselves. All universities have at least one main doctoral scholarship that, depending on the size of the university, supports dozens or hundreds of doctoral students. Some universities also have a main scholarship for masters students—though this supports a much smaller proportion of the relevant student population. Most universities also fund and offer a range of other scholarships, often targeted to students in specific subject areas, or to support students with particular costs – such as carrying out their research—and costs associated with professional development.

Universities also administer and award a number of scholarships funded from sources such as bequests, donations, industry, research funding and Crown Research Institutions. It can be difficult to determine a typical stipend from these types of awards as students may have multiple awards, may be part time only, or require only small amounts due to employer subsidies.

A large range of other scholarships are also available to postgraduate students, administered and awarded outside the universities themselves.

Universities may be aware that a student has one of these scholarships, for example when a student is being funded through a NZ Government Manaaki New Zealand Scholarship or through certain foreign-government schemes.

More often than not, however, the university does not know what scholarships or other forms of financial support, if any, a student has. Some students have their study paid for or subsidised by employers. A range of industry-funded scholarships and a large range of philanthropic scholarships are administered by organisations such as Universities New Zealand. Local Rotary Clubs or Masonic Lodges are examples of organisations that provide scholarships to help students from their geographical areas to get to university. Iwi are also increasingly directly funding postgraduate students via stipends, which is not always visible to universities.

No reliable information is available on the financial arrangements of each postgraduate student at university. Universities generally assume if a student is successfully progressing in their studies, they have found a way of supporting themselves financially.

There are some insights in the Integrated Data Infrastructure (IDI) and Census. Focusing on just domestic students who were studying for a doctorate in 2018 (N=4920):

- 40% were aged 40 or more
- 71% were working while studying—a mix of full- and part-time
- 63% reported an income below \$50,000
- 17% were employed to teach or tutor at the place where they were studying.

#### University scholarships and stipends are not a wage

Postgraduate scholarships and stipends are not intended to create any sort of employment relationship with the university.

All university-funded scholarships are contributions towards the cost of a student's studies. Students are not required to do work for the university to earn their scholarship/stipend, though many are given the opportunity (and encouraged) to take on additional paid work by doing tutoring, marking or laboratory demonstrating to gain practical experience that will help them gain employment in future. Income from this additional work is on top of any scholarship-related stipend. Because there is no work component to a scholarship/stipend, the money is not treated as earnings; consequently, stipends are not taxed. Any additional paid work is treated as income and tax is paid on it.

## University scholarships and stipends

This paper has nine attachments.

<u>Attachment 1</u> provides a summary of what universities know about scholarships and stipends for students studying at masters and doctoral levels. Attachment 1 has been reviewed by each university and confirmed as correct.

<u>Attachments 2 to 9</u> are the material provided by each university. This material was used to assemble the table in Attachment 1 and universities filled in a few gaps in Attachment 1 where information was not provided initially.

In reviewing all nine attachments provided please note:

- The Select Committee request did not specify what information was required. The material produced by universities therefore varies significantly and making comparisons is risky. For example: some universities report numbers of scholarship recipients as a weighted average, while others just report it as a headcount. As such the 'average amount per student' reported by each university should not be seen as a like-for-like figure for comparative purposes.
- Some students receive both a doctoral stipend from a university and a scholarship through a university or some other organisation. At some universities, postgraduate stipends are managed in one area and scholarships in one or more other areas. Information is not normally matched up in these situations, making exact counts of numbers of students receiving support problematic.
- Some students may have received a scholarship in the past but have used up their stipend entitlement. For example, they were given a scholarship for three years to complete doctoral studies but have extended to a fourth (unfunded) year.
- As mentioned earlier, a proportion of students receive scholarships and financial support directly from sources outside the university, including support from employers, industry scholarships,

philanthropic scholarships, public research funding, private funding and international funding support to some international students. Universities are often not aware of this support and, even when they are aware of it, do not record/report on it. As such, this table under-reports support provided to postgraduate students.

- Dollar figures are rounded to the nearest thousand where numbers are 7 digits (millions) or more.
- Different policies apply to who is eligible for scholarships at each university. There are many bespoke scholarships that are highly targeted to particular groups of students and/or projects (eg for Māori, women, first in family to get to university, for improving knowledge in a particular field or region, etc). These vary significantly from university to university.
- There is some double counting in places; for example, head counts include some students who started 2022 at Level 9 (masters) and finished the year having started Level 10 (doctoral studies).
- A significant number of scholarships available for doctoral or masters students are also available to honours students (Level 8). As such, some of the figures overstate the amount of support for Level 9 and 10 students.
- The 'other university funded scholarship schemes' include a wide range of things including full scholarships worth tens of thousands of dollars annually down to small grants or awards. These small grants and awards drag down overall averages significantly at some universities.

In looking at <u>Attachment 1</u>, you will see:

- There were 30,786 domestic and international students studying at one or both of Level 9 (masters) and 10 (doctorate) in 2022.
- Around 2,592 doctoral students received a university-funded stipend in 2022—approximately 26% of all doctoral students. Noting that stipends are a contribution towards living expenses while studying, stipends ranged from \$24,161 to \$29,500 annually with an average of \$26,344.
- All doctoral students who received a stipend from a university-funded scholarship also had their tuition fees waived.
- Around 307 masters students received a university-funded scholarship in 2022—approximately 1.5% of all masters students.
- At all but one university, students who received a scholarship for masters-level studies had their tuition fees waived.
- No student was required to do non-degree related work for their scholarship.
